Audit Findings

Audit Narrative

The audit of Sarasota County Sheriff's Office – Detention Center was conducted on May 13, 14 and 15, 2018, by James Aguiar, Jr., Certified PREA auditor. The area toured was a three-story building with a total of 12 different housing units (to include a Medical Housing Unit and Special Housing areas), a medical station, several multi-purpose rooms, a kitchen area, laundry, and programs areas for the inmates.

An entrance meeting was held with the facility staff. The following people were in attendance: Major Brian Meinberg, Captain David A Scott, Captain Dan Tutko, Lieutenant James Forrest, Lieutenant Jay Doyle, Lieutenant Arlene Tracy, Lieutenant Russell McManamy, Sergeant Mark Stone, Sergeant Mark Ontko, Sergeant Eleni Koenig, Sergeant Lewis Hirtzel, Sergeant Roberto Martinez, Deputy Lavelle, Administrative Assistant Mary Lang, Corrections Accreditation Manager Amanda Lewis, HAS Megan Taylor and DON Tonya Bellamy (Armor Medical).

Following the entrance meeting I toured the facility from 0830 hours to 0930 hours. I was escorted by PREA Coordinator Lt. Jay Doyle. During this tour I was able to conduct some interviews with staff and inmates. I also, reviewed all of their PREA related incident reports and their 30 day PREA Incident Reviews.

On the second and third day, I conducted some additional staff and inmate interviews and observed the interaction of the staff with the inmates inside their housing units into the evening shift.

During this PREA Audit the questions that were asked of all staff members, specialized staff members, medical/mental health members, and the inmate were the standard set of questions from the PREA Resource Center's Auditor's tools.

During this PREA Audit, there were a total of 92 inmate names requested to interview; and 07 refused the interview. The remaining 85 inmates, (three inmates who was limited English proficient, one hearing impaired inmate, one vision impaired inmate, nine LGBT inmates, two juveniles, one PREA alleged offender, two inmates with special management issues, and the rest were regular inmates) were interviewed with no PREA complaints or PREA issues.

I asked for a shift roster and randomly selected 40 security and civilian staff members to interview which included their specialized staff. Several specialized staff was interviewed to include Classification, SANE/SAFE nurse (from Safe Place and rape Crisis Center), Medical nurses and mental health worker, Intake staff, Juvenile Officers, Confinement Officers, Programs Coordinator, Training Sergeant, and Investigation staff.

Facility Characteristics

In July of 1956, a modern jail was constructed at the direction of Sheriff Ross Boyer. The cost of this facility was \$318,000 and included an apartment for Sheriff Boyer and his family on the second floor of the jail. Sheriff Boyer lived above the jail until July 1962, when staffing was increased and the need for the sheriff to live in the jail was no longer a necessity. Today, after major renovations, this structure, known as the "Old Courthouse," houses the Sarasota County clerk of the court and various other governmental entities, as well as several courtrooms. The recent renovation was designed to recreate the original "flavor" of the courthouse during its heyday.

In August of 1975, at the direction of Sheriff Jim Hardcastle, and at a cost of \$5.3 million, a second jail was constructed to hold an additional 214 inmates. This jail is still in use today, and is called the "west wing." At the present time, this wing houses females and new arrivals to the facility. Also located in the west wing area are programs and services, inmate property and classification, as well as office space for the facility's management.

In June of 1987, under the direction of Sheriff Geoffrey Monge, and at a cost of \$12.2 million, the "east wing" of the jail opened, which provided additional bed space for 540 inmates. This wing is a linear-style housing design, and comprises the main housing area for males, juveniles, administrative and punitively segregated inmates, and special management inmates. The recreation area is also located on the roof of the east wing.

In November of 2002, at a cost of \$15.5 million, a direct supervision wing was opened. This "north wing" provides bed space for 288 inmates. The new addition also includes a medical housing floor for 32 inmates, a new kitchen facility, inmate video visitation and administrative offices. Officers are on post within the cell pods and have direct inmate contact 24-hours-a-day, seven-days-a-week. Specialized training relating to the direct supervision philosophy and inmate behavior, rules and discipline must be acquired prior to assignment in the direct supervision wing.

Currently, Major Brian Meinberg is the corrections and court services division commander. His corrections staff includes 2 captains, 8 lieutenants, 20 sergeants. The jail currently operates on an annual budget of over \$34 million. Daily operations require a minimum of 71 deputies to exercise care, custody and control of incarcerated individuals. Inmate meals alone exceed over 2,800 per day. Approximately 40 commercial-sized loads of laundry are cleaned and distributed daily. The average daily population for the first quarter of 2018 was 901 inmates. The Sarasota County jail has a rated capacity of 1,026. The total number of arrests processed at the facility from January to December, 2017 was 12,222. In January through April, 2018 there were 3,576 individuals processed through the jail. In 2009, a new "open" booking area was unveiled. This change has provided for quicker transition into custody of arrestees and a safer environment for both the arrestees and staff.

The Sarasota County Sheriff Office – Detention Center does not impose a time limit on when an inmate may submit any grievances regarding an allegation of sexual abuse. They ensure that an inmate who alleges sexual abuse may submit a grievance without submitting it to a staff member who is the subject of the complaint, and such grievance is not referred to a staff member who is the subject of the complaint.

The Sarasota County Sheriff Office – Detention Center issues a final agency decision on the merits of any portion of a grievance alleging sexual abuse within 90 days of the initial filing of the grievance. Third parties, including fellow inmates, staff members, family members, attorneys, and outside advocates, are permitted to assist inmates in filing requests for administrative remedies relating to allegations of sexual abuse, and are also be permitted to file such requests on behalf of inmates.

The Sarasota County Sheriff Office – Detention Center has established procedures for the filing of an emergency grievance when the inmate is subject to a substantial risk of imminent sexual abuse. After receiving an emergency grievance alleging a substantial risk of imminent sexual abuse, the facility immediately forwards the grievance (or any portion thereof that alleges the substantial risk of imminent sexual abuse) to a level of review at which immediate corrective action is taken, and provides an initial response within 48 hours, and issues a final agency decision within 5 calendar days. The initial response and final agency decision documents the facilities' determination whether the inmate is in substantial risk of imminent sexual abuse and the action taken in response to the emergency grievance.

Where sexual abuse is alleged, the Sarasota County Sheriff Office uses investigators who have received special training in sexual abuse investigations. Investigators gather and preserve direct and circumstantial evidence, including any available physical and DNA evidence and any available electronic monitoring data; are interview alleged victims, suspected perpetrators, and witnesses; and are review prior complaints and reports of sexual abuse involving the suspected perpetrator.

When the quality of evidence appears to support criminal prosecution, the Sarasota County Sheriff Office conducts compelled interviews only after consulting with prosecutors as to whether compelled interviews may be an obstacle for subsequent criminal prosecution. The credibility of an alleged victim, suspect, or witness is assessed on an individual basis and is not determined by the person's status as inmate or staff. The agency does not require an inmate who alleges sexual abuse to submit to a polygraph examination or other truth telling device as a condition for proceeding with the investigation of such an allegation.

Administrative investigations include efforts to determine whether staff actions or failures to act contributed to the abuse; and are documented in written reports that include a description of the physical and testimonial evidence, the reasoning behind credibility assessments, and investigative facts and findings.

Criminal investigations are documented in a written report that contains a thorough description of physical, testimonial, and documentary evidence and attaches copies of all documentary evidence where feasible. Substantiated allegations of conduct that appears to be criminal are referred for prosecution.

The Sarasota County Sheriff Office retains all written reports for as long as the alleged abuser is incarcerated or employed by Sarasota County Sheriff Office, plus five years.

The departure of the alleged abuser or victim from the employment or control of the Sarasota County Sheriff's Office or agency does not provide a basis for terminating an investigation.
